- I. CALL TO ORDER George Langbein
 - In attendance: George Langbein, Frank Deluca, John Jones, Sandy Bernstein, Heather Chinn, Valerie Damiano and Bill Buttaggi
- II. REVIEW AND APPROVAL OF MARCH 2015 MINUTES Vicki Goss Motion made and seconded to approve the March 2015 minutes.
- III. OLD/NEW BUSINESS George Langbein
- Election of Board Members: George Langbein Tally of votes for two prospective Board members, Frank Deluca to a new three-year term and Bill Buttaggi to a first, three-year term; Doral Bylaws require that 10% of HOA members vote in person or by proxy in order to have a valid election, meaning that at least 16 votes must be cast; thanks to outgoing Board member Valerie Damiano for her service.
 - After tally of 25 ballots, Frank Deluce was elected for a new 3-year term and Bill Buttaggi was elected for a first 3-year term
- Reorganization of Board Responsibilities: George Langbein -- Outlines new responsibilities of Board members for the coming year; briefs the public on HOA accomplishments to date
- Review of Doral Solicitation for Bids/Proposals for Vendor Services: George Langbein, Frank Deluca -- Doral HOA recently asked several prospective vendors for bids/proposals for insurance coverage and financial audits; awards for these services will be made on the basis of the lowest cost, technically acceptable bids; vote on the selection of winning bids will proceed if prospective vendors have responded
 - Motion made, seconded and approved to have Daly Hammond & Associates complete the financial audit.
 - Motion made, seconded and approved to continue to use State Farm for insurance coverage.

Sandy Bernstein and the rest of the ARC reviewed at a high level the results of the ARC inspection. In general, it was thought that there were less deficiencies this year than last year. The ARC believe this can be attributed to the door hangers advertising the Inspection that were placed on all the doors of the TH/HO in the neighborhood.

The Board approved the new 2015 Updated ARC Guidelines that were placed on the Doral HOA Web Site.

The Board also approved the appointment of the Doral HOA Architecture Review Committee (ARC). The ARC will be initially staffed with two Co-Chairman on the Board (to be Heather Chinn and Sandy Bernstein for the coming year) and one non-Board Member (to be Valerie Damiano for the coming year).
