## **Meeting Minutes**

- I. CALL TO ORDER AND INTRODUCTIONS Jean Langbein
- II. MONTGOMERY COUNTY COUNCILMEMBER NANCY FLOREEN Discussion on topics of interest to HOAs in Montgomery County

- Montgomery County's upcoming election involves a major turnover due to term limits. Nancy Floreen encouraged the community to get involved, register, and vote. The budget for next year is being finalized – property taxes may go up if your property value has increased. Half of the 5.6 billion budget goes to schools. County has created training opportunities/programs to support HOA's and provide skills to deal with community conflict. Nancy advocated for homeowners to get involved and speak up on their needs to the new county representatives. Current county newsletters were available for the homeowners.

Quail Creek Court homeowner brought up the fact that they believe Quail Creek does not belong to Doral. This will be further addressed with the Board. Other issues mentioned by homeowners included paint policies, satellite dishes, and sheds. These issues will also be addressed by the ARC and Board.

    - Rules of voting were reviewed—16 ballets needed (10%). Summit Management. collected all ballets and tallied votes. Bill Buttaggi, Frank DeLuca, and Craig Jones were all elected for 3 year terms.

    - Financial status report. Overall, is HOA is healthy and receiving assessments.

    - Special Projects status update. Nothing to report

    - ARC status update. El Hadji continues to address homeowner concerns with paint policy and the issue of sheds. ARC guidelines to be revised as needed but it may involve revising the bylaws. El Hadji will collect all the changes for the board to review and discuss further.

    Motion made to replace all 4 lights. Voted and approved.
  - Status of tree at Brandon Green Circle Tree not doing well, it was under warranty. Greenskeeper to replace in the next coming weeks.
  - Vote on cleaning of trash enclosure and dry pond Greenskeeper quoted \$750.
    To clean trash enclosures Only needs to be done every couple years. Water needs to be brought in to power wash. Greenskeeper will clean dry pond for \$120 (1 hour) or for the amount of time needed. Motion made to have Greenkeeper to do both jobs. Voted and approved.
  - Vote on Second Addendum to DHA By-Laws Competitive Bids
    - Motion made and approved. \$750 to \$1500 and \$1500 to \$3k
  - Vote on Third Addendum to DHA By-Laws Administrative Resolution for <u>Collection of Assessments and Fines –Summit noted if there is a lien, with the</u> proposed addendum we wouldn't be able to collect for fines. Motion made to NOT accept changes to addendum. Order will remain the same.

### New Business:

- Determine if Board would like to proceed with the filing of a Complaint to pursue personal Judgments against two homeowners with balances of \$4,260.90 and \$3,199.67) Motion made and approved to move forward with personal judgment.
- Comments and Input by HOA and Summit Management: Summit Management Representative Nothing to add other than the results of the election.
